#### Item 1. Security and Issuer.

This Amendment No. 9 to Schedule 13D (this "Amendment") is being filed as an amendment to the initial statement on Schedule 13D relating to the Common Stock, \$0.01 par value per share ("Common Stock") of Xencor, Inc., a Delaware corporation (the "Issuer" or "Xencor") as filed with the Securities and Exchange Commission (the "SEC") on December 16, 2013 (the "Schedule 13D"), as amended by Amendment No. 1 filed June 20, 2014, as amended by Amendment No. 2 filed December 1, 2015, as amended by Amendment No. 3 filed February 14, 2017, as amended by Amendment No. 5 filed December 27, 2019, as amended by Amendment No. 6 filed April 8, 2020, as amended by Amendment No. 7 filed May 1, 2020 and as amended by Amendment No. 8 filed May 12, 2020 (as so amended, the "Schedule 13D"). The principal executive offices of the Issuer are located at 111 West Lemon Avenue, 2nd Floor, Monrovia, CA 91016. The Schedule 13D is hereby further amended and supplemented as follows:

#### Item 5. Interest in Securities of the Issuer.

Item 5(a) of the Schedule 13D is amended and supplemented as follows:

All of the percentages of beneficial ownership of the Reporting Persons set forth in this Schedule 13D are based on 57,004,786 shares of the Issuer's Common Stock reported to be outstanding as of April 29, 2020 in the Issuer's Quarterly Report on Form 10-Q for the quarter ended March 31, 2020.

As of May 19, 2020, John S. Stafford III beneficially owns 3,516,731 shares of the Common Stock of the Issuer, representing approximately 6.2% of the Issuer's outstanding shares of Common Stock. Mr. Stafford is the indirect beneficial owner of all 2,965,199 shares of Common Stock beneficially owned by Ronin Capital, LLC, representing approximately 5.2% of the Issuer's outstanding shares of Common Stock. Mr. Stafford, as the manager of Ronin Trading, LLC, also may be deemed to beneficially own the 551,532 shares of Common Stock beneficially owned by Ronin Trading, LLC, representing approximately 1.0% of the outstanding shares of Common Stock.

Subsequent to the filing of Amendment No. 8 to the Schedule 13D, the Reporting Persons engaged in the following transactions with respect to the Issuer's securities within the last sixty days prior to the filing of this Amendment:
